#### Reasons for revision

In the Industrial Systems Division, sales of heavy electrical equipment for overseas plants continued to perform strongly, as in the previous fiscal year. In addition, the resource drilling and exploration-related business and the aerospace and defense-related business also showed growth. In the Industrial Materials Division, the resin business for automotive parts for North America, among others, continued to perform steadily.

As a result, full-year net sales, operating profit, ordinary profit, and profit attributable to owners of parent are expected to exceed the previous forecasts.

Based on these factors, the Company has decided to upwardly revise its full-year consolidated financial results forecast.

## Reasons for revision

The Company's basic policy regarding profit distribution is to pay dividends that comprehensively take into account future business development, financial conditions, earnings trends, etc. under an appropriate capital policy, with the aim of providing continuous returns to shareholders and sustainably enhancing corporate value. Based on this policy, the Company will adopt a progressive dividend approach from the fiscal year ending March 31, 2026, in principle, maintaining or increasing dividends without reduction, with a target payout ratio of approximately 50%.

Regarding the consolidated financial results for the fiscal year ending March 31, 2026, considering that performance through the interim period has been steady and exceeded initial forecast, among others, the full-year financial results forecast is expected to be revised upward.

Accordingly, the year-end dividend forecast for the fiscal year ending March 31, 2026, is revised from \(\frac{1}{2}\)35.00 per share to \(\frac{1}{2}\)37.00 per share. As a result, the total annual dividend is expected to be \(\frac{1}{2}\)72.00 per share.
