## **Notice Concerning Organizational Reforms, Transfer of Operating Officers, and Other Personnel Transfer**

TACHIBANA ELETECH CO., LTD. (the “Company”) hereby announces that it will conduct organizational reforms, transfer of Operating Officers, and other personnel transfer, as follows.

### **1. Organizational reforms (effective April 1, 2026)**

Amid the rapidly advancing digitalization of society and evolving conditions in the global operating landscape, which are driving significant changes in customer needs and the business environment, the Company will implement organizational reforms effective April 1, 2026. These reforms aim to flexibly promote the new medium/long-term management plan.

[Key points in organizational reforms]

- (1) In Factory Automation Systems, the Company will enhance operational flexibility and reorganize strategic departments.
- (2) In Semiconductors and Electronic Devices, the Company will redefine organizational roles by realigning departments to better address specific customer requirements. Based on this, we will review personnel allocation and restructure our organization accordingly.
- (3) In Finance & Administration, the Company will implement organizational restructuring to enhance agility.

#### **<Factory Automation Systems>**

- (1) To accelerate the rollout of industrial devices, one of the Company’s strategic products, to the factory automation industry, the Company will split the Industrial Devices Dept. and reposition its functions directly under the Factory Automation Dept. 1 and the Factory Automation Dept. 2.

#### **<Semiconductors and Electronic Devices>**

- (1) To enhance organizational agility, Semiconductors & Electronic Devices Planning Division will be restructured as a department-level unit directly under the Director.
- (2) Organizations affiliated with the Semiconductors & Electronic Devices Division 1 and the Semiconductors

& Electronic Devices Division 2 will be restructured.

- (3) The Foreign Semiconductors & Electronic Devices Division 1 and the Foreign Semiconductors & Electronic Devices Division 2 will be merged to establish the Foreign Semiconductors & Electronic Devices Division.
- (4) The new Semiconductor Technology Promotion Office will be established as an organization dedicated to identifying alternate supply sources and determining which new products and technologies to introduce.
- (5) A new Renesas Business Operations Dept. will be established, dedicated to managing key suppliers.

**<Finance & Administration>**

- (1) The Personnel Dept. affiliated with the Administration Division will be repositioned directly under the director in charge of Finance & Administration, to enhance agility in addressing personnel issues.

**<Construction Safety Management System>**

- (1) To enable more agile management and operation from a Construction Industry Act compliance perspective, Construction Safety Management Office at headquarters and each branch office, which belong to the Construction Safety Management Control Office, will be abolished.
