Notice Concerning Unrealized Losses on Securities as of the End of the Third Quarter Ended December 31, 2025

(hereinafter, the “Bank”) hereby announces that it has calculated unrealized losses on the securities (bonds held to maturity) held by the Bank and its consolidated subsidiaries as of the end of the third quarter ended December 31, 2025. The total amount of the said unrealized losses is set out below.
