Notice of Determination of Exercise Price for Stock Warrants as Stock Options

With respect to stock warrants to be granted as stock options as resolved by the Board of Directors of Ichiyoshi Securities Co., Ltd. (the “Company”) on July 30, 2026, the exercise price for each stock warrant was determined today. Common shares issuable upon exercise of the stock warrants are currently intended to be delivered out of the Company’s treasury shares. Set forth below are the exercise price for each stock warrant and other related matters:

1. Exercise price for each stock warrant:
159,100 yen per each stock warrant (equivalent to 1,591 yen per share).
2. Total number of stock warrants granted:
4,881 stock warrants (the number of shares to be delivered upon exercise of each stock warrant shall be 100 shares).
3. Persons entitled to stock warrants and number of stock warrants granted:
1,081 persons consisting of Executive Advisers and Employees of the Company and its subsidiaries were granted 4,881 stock warrants.
4. Kind and number of shares to be delivered upon exercise of stock warrants:
488,100 shares of the Company’s common stock.
