BUSINESS RESULTS

1. Qualitative Information on Business Results

(1) Information on Business Results for Semi-annual Period

During the six months ended September 30, 2025 (from April 1 to September 30, 2025, hereinafter called "semi-annual period") of the current consolidated fiscal year, for economic conditions both domestic and abroad, there were concerns over the impact of the U.S. announcement of reciprocal tariffs in April, however subsequent reductions in tariff rates and delays in their implementation eased future uncertainties. On the other hand, the ongoing Russia-Ukraine war and the turmoil in the Middle East brought about uncertainties regarding the global economic outlook. Under this situation, the Bank of Japan (BOJ) maintained its policy interest rate unchanged to assess the impact of the U.S. reciprocal tariffs on the Japanese economy. Meanwhile, the U.S. Federal Reserve Board (FRB) lowered its policy interest rate in September for the first time in nine months, responding to deteriorating U.S. employment conditions and slowing inflation rate. The European Central Bank (ECB), which continued to cut policy interest rates until June, decided at its July meeting to keep its policy rate unchanged for the first time in a year, reflecting calming down of inflation and a partial recovery of European economies.

In the stock market, stock prices, which had plummeted globally in April, recovered quickly and then rose further reflecting the favorable situations that negotiations between U.S. and other countries led to reductions in mutual tariff rates and delays in their implementation. Although the Nikkei Stock Average (Nikkei 225) temporarily fell to \(\frac{\pmax}{30}\),792 in April, it rebounded sharply and renewed all-time high record in August, surpassing the previous record set in July 2024, as corporate earnings for April-June did not deteriorate as much as feared and companies actively conducted share buybacks. Subsequently, Nikkei 225 rose further, driven by strong earnings of U.S. high-tech companies and expectations for fiscal stimulus plan under the new government following the announcement of Prime Minister Ishiba's resignation, and it surpassed the major milestone of \(\frac{\pmax}{4}\)5,000 for the first time. Nikkei 225 ended at \(\frac{\pmax}{4}\)4,932 at the end of the six months period, a 26.2% increase compared with the end of March.

In the U.S. stock market, the New York Dow Jones Industrial Average (DJIA) temporarily fell to \$36,611 in April due to the announcement of mutual tariffs. However, with progress in tariff negotiations and solid corporate earnings in the financial and IT sectors, the DJIA surpassed its all-time high of December 2024 in August. In September, further growing expectations for an interest rate cut by the FRB due to worsening U.S. employment situations led to continued gains of prices, and the DJIA ended at \$46,397 at the end of the six months period, a 10.5% increase compared with the end of March.

In the bond market, the Japan's 10-year government bond yield temporarily fell to 1.105% in April but then tuned to rise as uncertainty in the external environment eased. Furthermore, concerns over fiscal deterioration have emerged due to persistent rise in domestic prices and the victory of opposition parties pledging a consumption tax cut in the Upper House election in July. As a result, the Japan's 10-year government bond yield at the end of the semi-annual period reached 1.645%, rising to its highest level since July 2008. The U.S. 10-year government bond yield, which had fallen below 4% in April, turned to rise thereafter. However, following the FRB's rate cut in September, The U.S. 10-year government bond yield ended at 4.149% at the end of the semi-annual period, a 0.059% decline compared with the end of March.

In the foreign exchange market, after the Yen appreciated 139.86 yen to the Dollar in April in response to the announcement of mutual tariffs, the Yen weakened to 150.91 yen to the Dollar in August. Subsequently, due to the narrowing interest rate differential between Japan and the US, the Yen ended at 147.87 yen to the Dollar at the end of the semi-annual period, 2.06 yen appreciation from the end of March. The Euro remained in a high range, partly due to the ECB's halting interest rate cuts, and the Yen ended at 173.56 yen to the Euro at the end of the semi-annual period, 11.34 yen depreciation from the end of March.

In this environment, we made efforts to offer "unique in-season financial products" for responding to customers'

varied needs. Also we conducted active financial management from the view point of effective management of shareholders' equity.

For the semi-annual period, operating revenue was 4,317 million yen,(0.5% increase from the semi-annual period of the previous fiscal year), net operating revenue was 4,256 million yen (0.1% decrease), operating income was 1,730 million yen (4.2% increase), ordinary profit was 2,111 million yen (14.1% increase), and net profit attributable to owners of the parent company was 2,451 million yen (6.6% decrease).

Details of the semi-annual period's results are as follows:

(1) Commission Received

The total commission received resulted 1,804 million yen (15.9% increase from the semi-annual period of previous fiscal year), the details of which are shown below:

(Brokerage Commission)

Brokerage commission on equity securities was 756 million yen (24.4% increase). Total amount of brokerage commission including those on beneficiary securities (Exchange Traded Funds) was 770 million yen (23.7% increase).

(Commission for Underwriting, Secondary Distribution and Solicitation for Selling and Others for Professional Investors)

The amount of commission for underwriting, secondary distribution and solicitation for selling and others for professional investors was 5 million yen (15.7% decrease).

(Fee for Offering, Secondary Distribution and Solicitation for Selling and Others for Professional Investors) The amount of fees for offering, secondary distribution and solicitation for selling and others for professional investors was 636 million yen (0.6% increase), due to an increase of handling of beneficiary securities (investment trusts).

(Other Commission Received)

The amount of other commission received consisting mainly of trailer fee of beneficiary securities (investment trusts) was 392 million yen (32.6% increase).

② Net trading Income

Net trading income of equities, etc. resulted in a loss of 30 million yen (a loss of 40 million yen in the semi-annual period of previous fiscal year). Net trading income of bonds etc. resulted in a gain of 1,607 million yen (24.7% decrease). Net trading income on other trading, consisting mainly of foreign exchange derivatives resulted in a loss of 9 million yen (a loss of 154 million yen in the semi-annual period of previous fiscal year). As a result, net trading income resulted in a gain of 1,567 million yen (19.2% decrease).

③ Net Financial Income

Net financial income was 875 million yen (12.5% increase from the semi-annual period of previous fiscal year), as a result of deducting 61 million yen (75.1% increase) of financial expenses from 936 million yen (15.2% increase) of financial revenue.

4 Selling, General and Administrative Expenses

Selling, general and administrative expenses were 2,526 million yen (2.9% decrease from the semi-annual period of previous fiscal year).

(5) Non-operating Income and Expenses

Non-operating income, consisting mainly of dividend received, totaled 434 million yen (7.1% decrease from the semi-annual period of previous fiscal year), while non-operating expenses were 53 million yen (80.6% decrease).

As a result, net non-operating income amounted to 381 million yen (100.4% increase).

(6) Extraordinary Income and Loss

Extraordinary income was 1,546 million yen (23.6% decrease from the semi-annual period of previous fiscal year), as a result of sales of investment securities, while extraordinary loss was 30 million yen (409.8% increase) including loss on sales of investment securities.

As a result, net extraordinary income amounted to 1,516 million yen (24.9% decrease).

(2) Information on Financial Condition for Semi-annual Period

(1) Assets

Current assets as of September 30, 2025 were 51,977 million yen, increased by 5,681 million yen from previous fiscal year end. This is mainly because, while trading products decreased by 2,912 million yen, cash and deposits increased by 5,745 million yen and segregated deposits increased by 1,294 million yen and trade date accrual increased by 1,150 million yen. Non-current assets as of September 30, 2025 were 29,885 million yen and decreased by 2,417 million yen from previous fiscal year end. This is because investment securities decreased by 2,450 million yen.

As a result, the total assets of September 30, 2025 were 81,862 million yen, increased by 3,264 million yen from previous fiscal year end.

2 Liabilities

Current liabilities as of September 30, 2025 were 26,149 million yen, increased by 1,607 million yen from previous fiscal year end. This is mainly because, while short-term borrowings decreased by 500 million yen and trade date accrual decreased by 494-million-yen, deposit received increased by 3,000 million yen. Non-current liabilities as of September 30, 2025 were 2,953 million yen, increased by 528 million yen from previous fiscal year end. As a result, the total liabilities as of September 30, 2025 were 29,124 million yen, increased by 2,136 million yen from previous fiscal year end.

③ Net Assets

Within net asset, valuation difference on available for sale securities increased by 590 million yen and retained earnings increased by 537 million yen from previous fiscal year end.

As a result, net assets as of September 30, 2025 were 52,737 million yen, increased by 1,128 million yen from previous fiscal year end.

(3) Future Outlook

Consolidated operating revenues are mainly comprised of commissions received and trading income, related to the securities markets, the majority of which are coming from the stock and bond markets. In order to mitigate the impact of favorable or unfavorable conditions in the stock and bond markets on our financial results, we are striving to ensure revenue stability by diversifying our revenue sources. Even so, our business performance may still be affected by trends in the securities markets and may fluctuate significantly. In addition, sharp fluctuations in the domestic and foreign financial instrument markets could result in large valuation gains or losses on financial instruments held by ourselves.

In general, securities markets and foreign exchange markets fluctuate, reflecting variety of factors such as domestic and international political and economic conditions, interest rates, and corporate earnings. Therefore, in order to forecast our consolidated financial results, it is necessary to accurately grasp future market trends while predicting these factors in advance, but the reality is that it is nearly impossible to achieve this. In a situation where such uncertain factors are likely to cause a large discrepancy between forecasts and actual results, daring to disclose forecast of financial results may result in sending a false message to the market, which may impede fair stock price formation.

For the aforementioned reasons, we will not disclose forecast of financial results, but will instead endeavor to disclose financial results as early as possible, and will announce such figures as preliminary figures around the 10th business day after the end of the fiscal year or the end of the quarter, when consolidated financial results are almost finalized.
