Notice regarding the transfer of a specific subsidiary

Tokyo, April 28, 2026 --- NEC Capital Solutions Limited (hereinafter, “the Company”) announces that, at a meeting of its Board of Directors held today, its consolidated subsidiary, RISA Partners, Inc. has decided to invest in the following silent partnership, which will become a specific subsidiary of the Company.

1. Reasons for the change

RISA Partners, Inc. (hereinafter, "RISA Partners"), a consolidated subsidiary of the Company, will make investment in a silent partnership Godo Kaisha R Office1 which acquires and manages trust beneficial interests whose trust property is real estate. Consequently, the total amount of investment received by the silent partnership is equivalent to 10% or more of the Company’s capital, and said partnership will be considered a specific subsidiary of the Company.
