Notice Concerning Changes in Organization, Changes in Representative Corporate Executive Officers and Other Personnel

Mitsubishi Estate Co., Ltd. (hereafter "Mitsubishi Estate" or "the Company") hereby announces that it has decided to make the following organizational changes: changes in Representative Corporate Executive Officers and other personnel as well as candidates for Directors to be submitted at the Ordinary General Meeting of Shareholders scheduled to be held in the latter half of June 2025, and candidates for committee members of the Nominating Committee, Audit Committee and Remuneration Committee to be submitted at the Board of Directors' Meeting to be held after the Ordinary General Meeting of Shareholders.

## I. Organizational Changes

(Effective as of April 1, 2025)

The Company will make the following organizational changes with a view to achieving further growth going forward.

#### 1. Innovation and Business Transformation Group

(1) Establishment of the Media Development Office

To improve revenue and ensure the efficient management of the Mitsubishi Estate Group's assets from an advertising perspective, the Media Development Office will be established in the Business Creation Department, as an organization tasked with establishing new media, developing, planning, formulating and implementing the use of existing media, and providing consulting services.

#### 2. Commercial Property Business Group

(1) Establishment of the Core Logistics Business Promotion Office

To strengthen the promotion of core logistics facilities directly connected to expressway interchanges which support next-generation mobility including autonomously driven trucks, the Core Logistics Business Promotion Office will be established in the Logistics Facilities Development Department.

#### 3. Marunouchi Property Business Group

(1) Establishment of the Retail Property Business Department

To consolidate and reinforce company-wide retail functions, the Retail Property Business Office in the Commercial Property Management Department will be transferred to the Marunouchi Property Business Group, and following the integration of each department's retail functions as the Retail Property Business Department.

#### (2) Establishment of the IP Business Office

To strengthen the implementation structure of the IP Business, the IP Business Office will be set up in the newly established Retail Property Business Department, integrating IP Business functions handled by the Content Business Planning and Operation Department.

#### (3) Establishment of the Area Management Business Department

To enhance branding of the Otemachi-Marunouchi-Yurakucho area, the Area Management Business Department will be newly established. Concurrently, the public space management functions and functions including the promotion of services to workers handled by the Area Management Planning Department, along with area event management functions and operating functions such as hall and conference signage handled by the Content Business Planning and Operation Department, will be transferred to the new department.

### (4) Establishment of the Urban Development Promotion Department

To enhance R&D functions in urban development, the Urban Development Promotion Department will be newly established, with functions of the Urban Planning Department and some functions of the Area Management Planning Department transferred to the new department.

(5) Elimination of the Area Management Planning Department, Content Business Planning and Operation Department and Urban Planning Department

In connection with the newly established organizations detailed in (2) to (4) above, the Area Management Planning Department, Content Business Planning and Operation Department and Urban Planning Department will be eliminated.

#### 4. Corporate Group

(1) Establishment of the Planning and Research Department

To strengthen PR activities with government entities, economic groups and real estate-related groups, and to enhance research and analysis functions covering economic and real estate market conditions—currently handled by the Corporate Planning Department—the Planning and Research Department will be newly established.

#### 5. Other

(1) Establishment of the Brand Strategy Committee and Brand Strategy Subcommittee

To develop and reinforce a company-wide framework for the deliberation and promotion of brand management, including the brand strategy of the Mitsubishi Estate Group and the formulation of brand penetration initiatives, a Brand Strategy Committee chaired by the President & Chief Executive Officer will be established as a new meeting body, with the Brand Strategy Subcommittee newly established as a subordinate organization to the committee.
