<u>Notice Concerning Acquisition of Comprehensive Assessment System for Built Environment Efficiency</u> <u>("CASBEE") Certification for Buildings (New Construction) and</u> <u>Certification for CASBEE for Real Estate</u>

Japan Logistics Fund, Inc. (hereinafter referred to as "JLF") announced today that one property listed below has received Comprehensive Assessment System for Built Environment Efficiency ("CASBEE") Certification for Buildings (New Construction) and three properties listed below have received Certification for CASBEE for Real Estate.

1. Overview of CASBEE Certification

CASBEE is a method designed to comprehensively assess the environmental efficiency of buildings and promoted throughout Japan under the guidance of the Ministry of Land, Infrastructure Transport and Tourism.

CASBEE Certification is a system where third-party institutions examine and certify assessment results prepared in accordance with CASBEE for New Construction or CASBEE for Real Estate, etc. CASBEE Certification for Buildings (New Construction) is based on CASBEE for New Construction, which is evaluated based on the design details of new construction, and is rated in five levels (from five stars " $\star \star \star \star$ " ("S") to two stars " \star " ("C")).

In addition, Certification for CASBEE for Real Estate is based on CASBEE for Real Estate, which covers existing buildings that have been completed for at least one year, and evaluates the overall environmental performance of buildings in four levels (from five stars " $\star \star \star \star \star$ " ("S") to two stars " $\star \star \star$ " ("B")).

3. Future Measures

With the acquisition of CASBEE Certification for Buildings (New Construction) and Certification for CASBEE for Real Estate, the percentage of portfolio with green building certification obtained by JLF is now 69.8%.
