Notice Regarding the Accident at Kajigaya Station on the Den-en-toshi Line

At approximately 11:04 p.m. on Sunday, October 5, 2025, a train collision and derailment occurred at Kajigaya Station on the Den-en-toshi Line operated by Tokyu Railways, a wholly owned subsidiary.

We sincerely apologize for the inconvenience caused to our customers and other parties involved, and would like to provide further details as follows:

1. Overview of the Accident

- (1) Accident Type: Train collision and partial derailment
- (2) Date and Time: October 5, 2025, approximately 11:04 p.m.
- (3) Location: Kajigaya Station on the Den-en-Toshi Line, Kawasaki-shi, Kanagawa Pref.
- (4) Involved Trains:

Train 1: Local train from Chuo-rinkan to Shibuya

(10cars, owned by Tokyu Railways : 2135F)

Train 2: Deadhead train entering the lead-in line at Kajigaya Station

(10cars, owned by Tokyu Railways : 5101F)

(5) Operational Impact:

October 5, 2025 (Sunday)

Service suspended on the entire Den-en-toshi Line from approximately 11:04 p.m.

Outbound service resumed on the Den-en-toshi Line at approximately 2:10 a.m. on October 6.

* Inbound line service for October 5th ended.

October 6, 2025 (Monday)

From the first train

Den-en-toshi Line:

Service operated only between Saginuma Station and Chuo-rinkan Station.

* Operated with fewer trains than scheduled

* Service suspended between Shibuya Station and Saginuma Station

Oimachi Line:

Service operated only between Oimachi Station and Futako-tamagawa Station.

* Operated with fewer trains than scheduled

* Service suspended between Futako-tamagawa Station and Mizonokuchi Station.

Around 11 a.m.

An investigation by the Japan Transport Safety Board began

Around 10:20 p.m.

The Japan Transport Safety Board's investigation concluded, and preparations for full resumption began

Around 12 p.m.

Full line operations resumed

(6) Accident Details:

Train 1 collided with Train 2, causing the first car of Train 2 to partially derail.

(7) Human Casualties: None

(8) Cause of the Accident: Under investigation
