3. Partial Change to Operational Organization (as of June 27, 2025)


(1) Purpose and Details of Change

The Company received approval for the "Partial amendments to the Articles of Incorporation" proposal submitted at the 104th Annual General Meeting of Shareholders with the aim of enhancing corporate governance, and has transitioned to a Company with an Audit and Supervisory Committee as of the conclusion of the said Annual General Meeting of Shareholders. In conjunction with this, in order to

further strengthen compliance that is a key issue in corporate governance, the Company has decided to consolidate the previously separate divisions in charge of risk management, legal affairs, and internal reporting and newly establish the Compliance Department. By integrating the handling of compliance, etc. across the entire Group, from the collection of risk information to investigation and prevention of recurrence, into the said department, the Company will more quickly and appropriately address materialized risk and strive to prevent risk materialization.


(2) Organization chart
