Notice of Changes in Shareholder Benefits Program (from March 31, 2026)

As mentioned in the news release dated October 31, Keikyu Corporation (the "Company") has agreed to conduct a joint review with Keisei Electric Railway Co., Ltd. (hereinafter, "Keisei Electric Railway") for the purpose of realizing sustainable railway lines and further enhancing airport access for the realization of a tourism-leading nation, etc. As part of this agreement, the Company hereby announces that it has resolved to begin mutual cooperation among both companies' shareholder benefit programs and to change its shareholder benefit program.

1. Purpose of the changes

As part of the agreement-based initiative, the Company will establish a new shareholder benefit that leverages the regional connection of mutual direct access, which aims to provide even greater investment and holding appeal to the shareholders of both companies.

2. Details of the changes

(1) Establishment of a new exchange system for the Company's "All Train & Bus Line Ticket" and "Narita-Kaiun Pass"

We will establish a new system for exchanging three "All Train & Bus Line Tickets" for one "Narita-Kaiun Pass," Keisei Electric Railway's special ticket.

(2) Begin mutual utilization of Keikyu Store and Keisei Store shopping discount coupons

The Keikyu Store shopping coupons provided on the "Keikyu Group Service Shareholder Benefit Coupons" issued by the Company will become usable at LIVRE KEISEI locations operated by Keisei Store Co., Ltd.

Furthermore, Keisei Store shopping discount coupons provided on the "Shareholder Courtesy Privilege Coupon" issued by Keisei Electric Railway will become usable at Keikyu Store locations.

3. Implementation period

This will be implemented starting with the dispatch of benefits to shareholders recorded in the shareholder register as of the record date of March 31, 2026. (Scheduled to be sent out in the first half of the FY2026)
