4. Partial changes to organization of operations

Formation of the Hotel Business Division

- In order to maximize consolidated ROA in the hotel segment, a new "Hotel Business Department" will be established in the Real Estate and Commercial Business Headquarters, with "Business Strategies Section ", "Asset Section," and "Takayama Office" set up as a system for unifying strategies for hotel assets and hotel operations.
- (2) The "Kyoto Office, Hotel Business Strategies Section, Group Business Management Department " will be abolished as its role will have concluded.
- (3) As a result of the above, the "Hotel Business Strategies Section, Group Business Management Department " position will be abolished.
