Notice Concerning Partial Revisions to the Business Organization and Changes in Representative Directors and Officers

Nankai Electric Railway Co., Ltd. (the “Company,” which plans to spin off its railway business on April 1, 2026 and change its trade name to NANKAI Co., Ltd.; hereinafter referred to as “NANKAI Co., Ltd.”) hereby announces that, at the meeting of the Board of Directors held today, it resolved to implement partial revisions to its business organization, changes in Corporate Officers with Special Titles, and changes in Representative Directors, all effective April 1, 2026, as well as changes in Directors scheduled to take effect on the date of the Annual General Meeting of Shareholders scheduled for June 2026, as described below.

In addition, the Company also announces the executive structure and business organization of Nankai Electric Railway Co., Ltd., which is scheduled to succeed the railway business through an absorption-type split effective April 1, 2026 (and which is scheduled to change its trade name from Nankai Railway Split Preparatory Corporation to Nankai Electric Railway Co., Ltd. on the same date; hereinafter referred to as “New Nankai Electric Railway Co., Ltd.”).

I. NANKAI Co., Ltd.

1. Partial revisions to the business organization (effective April 1, 2026)

In order to clarify and strengthen the functions performed for the Group as a whole, the business organization will be partially revised. The principal revisions are as follows:

(1) Division in charge of Group-wide strategic management function

Keiei-Senryaku-Shitsu will be renamed *Keiei-Senryaku-Hombu* (no change to the English organization name) and will serve as the organization responsible for overseeing group-wide business strategy and group governance. Its responsibilities will include formulating the long-term management vision, restructuring the business portfolio, and promoting M&A initiatives.

(2) Command-center function for “developing a railway corridor that continues to be chosen”

In order to strengthen the command-center function for the long-term execution of the strategy of “developing a railway corridor that continues to be chosen,” Division of Community Development & Promotion and Public Transportation Division will be integrated to establish Division of Railway Corridor Development Strategy. Within this division, Department of Railway Corridor Development Strategy will be created to formulate strategies for key areas, comprehensively coordinate related departments, and develop co-creation partnerships, among other initiatives. In addition, the tourism business will be positioned as a contributor to the strategy of “developing a railway corridor that continues to be chosen.” To maximize tourism-related revenue across the entire Group, Tourism Strategy Department will be established within the division.

(3) Business divisions driving Group-wide growth

1) Real Estate Business Division

In order to achieve a significant expansion of the real estate business, Real Estate Strategy Department will be established within Real Estate Business Division to drive the formulation and implementation of the growth strategies for the real estate segment as a whole.

2) Business Strategy Division

To consolidate functions responsible for new business development, Business Strategy Department and President's Special Projects will be reorganized to establish Business Strategy Division. Within this division, Business Development Department, which will be responsible for scaling up priority businesses such as the e-sports business, and New Business Development Department, which will be responsible for identifying and nurturing new business opportunities, will be established.

(4) Group corporate division supporting the Group as a whole

To strengthen group corporate functions that support the Group as a whole and to enhance organizational flexibility, the Company will transition to a system of corporate officer oversight. In connection with this change, the Risk Management Division will be renamed Risk Management Department, and Internal Audits Division will be renamed Internal Audits Department.

In addition, in order to centralize and strengthen legal functions, the legal functions of Department of General Affairs & Public Relations and Department of Strategic Legal Affairs will be integrated to establish Legal Department.

II. New Nankai Electric Railway Co., Ltd.

1. Business organization (effective April 1, 2026)

From the perspective of establishing an organizational structure that enables New Nankai Electric Railway Co., Ltd. to formulate and execute effective measures to address key challenges, a business organization will be established. The principal details are as follows:

(1) Management of a sustainable railway business and stable operation as an operating company

Corporate Strategy Department will be established to take charge of company-wide strategies, including formulating management strategies for a sustainable railway business, leading business transformation through digital transformation (DX), and formulating appropriate revenue/expenditure and investment plans. The department will also be responsible for certain corporate functions such as general affairs, public relations, and accounting. In addition, to perform essential corporate functions as an operating company, Human Resources Department, Risk Management Department, and Internal Audits Department will be established. These functions will be operated in coordination with NANKAI Co., Ltd.

(2) Promotion of the Naniwasuji Line business

Naniwasuji Line Business Department will be established as an organization reporting directly to the President. In coordination with NANKAI Co., Ltd., this department will be responsible for promoting the Naniwasuji Line business.

(3) Ensuring safety and security

Railway Division will be established to oversee railway operations, with the General Manager of the division serving as the Chief Safety Officer. Within Railway Division, the following departments will be established to strengthen the transport safety management system: Safety Innovation Department, Sales Planning Department, Operations and Rolling Stock Department, Station-Area Development Department, Facilities Department.

(4) Enhancing earning power

To enhance the company's earning power, Sales Planning Department will be established within Railway Division to formulate sales strategies based on data-driven marketing and implement sales initiatives based on them. In addition, Sales Planning Department will also serve a cross-functional role in promoting digital transformation (DX) within Railway Division by providing support for DX initiatives across all departments.

2. Officer structure

To establish a robust management structure, the officers of New Nankai Electric Railway Co., Ltd. have been determined as follows. These appointments are scheduled to be formally approved at the company's extraordinary general meeting of shareholders and at the Board of Directors meeting to be held thereafter.
