(3) Reason

The Company regards the return of profits to shareholders as one of its most important management priorities. Based on this view, while comprehensively considering the business environment surrounding the Group, the need for internal reserves to prepare for future business expansion, and other factors, the Company's basic policy is to ensure stable and long-term dividends and to enhance shareholder returns through flexible share repurchases in response to changes in the business environment.

In accordance with this policy, the Company has decided to pay an interim ordinary dividend of ¥38 per share, taking into comprehensive consideration the dividend policy set forth in the 6th Medium-Term Management Plan and other factors. The year-end dividend forecast remains unchanged at ¥38 per share. Accordingly, the annual dividend for the fiscal year ending March 31, 2026, is expected to total ¥76 per share, an increase of ¥6 compared with the previous fiscal year.
