# Monthly Sales Flash Report October 2025

## ■ Monthly Sales Update – BOOKOFF Operations in Japan

Existing store sales in BOOKOFF Operations in Japan increased by 8.9% year on year (total store sales increased by 9.5%). Net sales of jewelry/watches/brand bags, trading cards/hobby goods, apparel, and home appliances/smart phones exceeded those of the same month last year, contributing to the overall growth in existing store sales.
