### **Notice Regarding Reorganization and Changes of Officers**

Yamatane Corporation (the “Company”) hereby announces that, at a meeting of the Board of Directors held on February 17, 2026, it has resolved the following reorganization and changes of officers.

#### 1. Reorganization (effective April 1, 2026)

\* The structures of the organization and in-house companies are shown in the attached document.

(1) The Purpose Promotion Department (tentative name) will be established as an organization directly controlled by the President.

(2) Corporate Division

(i) The Data Business Solution Office will be established.

(ii) The Digital Technology Promotion Section, Digital Project Promotion Section, and WMS Promotion Section of the Digital Innovation Department will be abolished, and the Digital Project Promotion Section 1 and Digital Project Promotion Section 2 will be established.

(3) Administration Division

(i) The General Affairs Section and the BCP Section will be established under the General Affairs Department.

(ii) The Human Resources Section and the Labor Relations Section will be established under the Human Resources Department.

(4) Logistics Services Company

(i) The DX Promotion Department will be established.

(ii) The Sales Department of the Kanto Branch and the Sales Department of the Kansai Branch will be merged as the Sales Department.

(iii) The Sales Section 1, Sales Section 2, Sales Section 3, Transportation Distribution Section, 3R Sales Section, and Wide-Area Sales Section will be established under the Sales Department.

(iv) The International Sales Department of the Kanto Branch will be placed as the International Sales Department.

(v) The Moving Operations Section, International Moving Operations Section, Moving Export Section, and Moving Import Section will be transferred to the International Business

Department as the International Moving Operations Section, the International Moving Sales Section, the International Moving Export Section, and the International Moving Import Section, respectively.

- (vi) The International Moving Shipping Section will be established under the International Sales Department.
- (vii) The Supply Chain Promotion Section, the Sales Development Section, and the International Logistics Sales Section will be established under the SCM Promotion Department.
- (viii) The Quality Improvement Section will be established under the Operations Department of the Kanto Branch.
- (ix) The SLIMS Center of Anzen Office, Block 2, Kanto Branch will be abolished, and the 3R Sales Section will be established.

#### (5) Food Business Company

- (i) The business department system will be introduced, and the Rice Business Department, the Processed Food Business Department, the Local Production Business Department, and the Agri-Innovation Business Department will be established.
- (ii) The Logistics Planning Office will be reorganized as the Logistics Planning Department.
- (iii) The Rice Purchasing & Sales Department, the Sales Department, the Production Department (Inzai Rice Mill Factory), and the Quality Assurance Department as well as Nousan Best Partner Co., Ltd. and SINRIKI Co., Ltd. will be placed under the umbrella of the Rice Business Department.
- (iv) Shokukai Co., Ltd. and T.M.L Co., Ltd. will be placed under the umbrella of the Processed Food Business Department.
- (v) The Local Production Solutions Section, BLUE SEED NIIGATA CORPORATION and AgriBase Tsuji Co., Ltd. will be placed under the umbrella of the Local Production Business Department.

#### (6) Real Estate Business Company

- (i) The Technology Management Section, Management Section 1, and Management Section 2 will be established under the PM Business Department.
- (ii) The Shinjuku Office will be transferred to the Management Section 2.
- (iii) The Administration Section and the Accounting Section will be established under the Administration Department.
