SKY Perfect JSAT Holdings Inc. (Head Office: Minato-ku, Tokyo; Representative Director, President: Eiichi Yonekura) announces that SKY Perfect JSAT Corporation (Head Office: Minato-ku, Tokyo; Representative Director, President & Chief Executive Officer: Eiichi Yonekura) established a special purpose company together with Mitsubishi Electric Corporation (Head Office: Tokyo; President & CEO: Kei Uruma), and Mitsui & Co., Ltd. (Head Office: Tokyo; President & Chief Executive Officer: Kenichi Hori) on January 26, 2026, as follows.

SKY Perfect JSAT Corporation (Head Office: Tokyo; Representative Director, President & Chief Executive Officer: Eiichi Yonekura; hereinafter “SKY Perfect JSAT”), hereby announces that, together with Mitsubishi Electric Corporation (Head Office: Tokyo; President & CEO: Kei Uruma; hereinafter “Mitsubishi Electric”), and Mitsui & Co., Ltd. (Head Office: Tokyo; President & Chief Executive Officer: Kenichi Hori; hereinafter “Mitsui”), it established a special purpose company (hereinafter “the SPC”) on January 26, 2026.

The SPC will serve as the contracting entity for the Ministry of Defense(MOD)’s publicly announced “Satellite Constellation Project” (hereinafter “the Project”), which was jointly awarded on December 24, 2025, to SKY Perfect JSAT, Mitsubishi Electric, Mitsui, Institute for Q-shu Pioneers of Space Inc. (Head Office: Fukuoka; President and Representative Director: Shunsuke Ohnishi), Synspective Inc. (Head Office: Tokyo; CEO: Motoyuki Arai), Axelspace Corporation (Head Office: Tokyo; President & CEO: Yuya Nakamura), and Mitsui Bussan Aerospace Co., Ltd. (Head Office: Tokyo; President & CEO: Morihiro Aoki). SKY Perfect JSAT and Mitsubishi Electric will be the largest shareholders with equal ownership stakes, and each company will appoint a Representative Director and Co-CEO to lead the SPC.

On January 19, 2026, the three companies concluded a Basic Agreement (hereinafter “the Agreement”) with the MOD regarding the Project. With the establishment of the SPC, the three companies have satisfied the Agreement’s requirement that the awardees form an operating entity. The SPC is scheduled to enter into a formal project contract with MOD in February.

Since its founding in 1985, SKY Perfect JSAT has accumulated four decades of experience, technology, facilities, and other assets through its space business. By leveraging these assets and operating the SPC, SKY Perfect JSAT is committed to contributing to the steady execution of the Project and to strengthening Japan’s national security and defense industrial base.
