### Notice of Organization and Personnel Changes

SKY Perfect JSAT Holdings Inc. (Head Office: Minato-ku, Tokyo; Representative Director, President: Eiichi Yonekura) announces that it resolved the organizational and personnel changes following the merger with its wholly owned subsidiary, SKY Perfect JSAT Corporation, effective April 1, 2026, as disclosed in the notice titled “Notice of Organization Changes and Appointment of Executive Officers” dated January 7, 2026.

#### 1. Organization Changes (Effective April 1, 2026)

##### <Corporate Administration Unit>

- The Secretary Division will be dissolved, and its executive secretarial functions will be transferred to the Corporate Planning Division or the Planning & Administration Division of each Unit.

##### <Media Business Unit>

###### ◇ HIKARI Alliance Business Group

- The FTTH System Division will be dissolved, and its functions will be transferred to the Business Planning Division.

###### ◇ Media Solutions Business Group

- The Infrastructure Design Business Division and the Media HUB Business Division will be newly established through the division of the functions of the Business Innovation Division.
- The Media Network Business Division will be newly established, and the technical and operational functions will be transferred from the Media Business Division of the Space Business Unit.

##### <Space Business Unit>

###### ◇ Space Solution Business Group

- The Frontier Business Division will be newly established for the purpose of enhancing the sales functions for the maritime/aero market, and developing the new services.
- The Media Business Division will be dissolved, and its functions will be transferred to the Media Business Unit.

###### ◇ Space National Security Business Group

- The Intelligence Security Division and the National Security Engineering Division will be integrated into the Engineering Security Division.

###### ◇ Space Engineering Group


- The Engineering Planning Division will be dissolved, and its functions will be transferred to the Ground System Division and the Planning & Administration Division of the Business Strategy Group.
