(Head Office: Minato-ku, Tokyo; Representative: Kimihiko Takabe), a wholly owned subsidiary of ITOCHU Corporation, as follows.

SKY Perfect JSAT Corporation (Head Office: Minato-ku, Tokyo; Representative Director, President & Chief Executive Officer: Eiichi Yonekura; hereinafter “SKY Perfect JSAT”) hereby announces that it has resolved to transfer a portion (32%) of the issued shares of its consolidated subsidiary, SKY Perfect Pictures Inc. (Head Office: Minato-ku, Tokyo; President and Representative Director: Atsushi Osanai; hereinafter “SPP”), to iRightsport Inc. (Head Office: Minato-ku, Tokyo; Representative: Kimihiko Takabe; hereinafter “iRightsport”), a wholly owned subsidiary of ITOCHU Corporation.

As a result of this partial share transfer, iRightsport’s shareholding ratio in SPP will become 49% in total, combining the shares contributed in kind by ITOCHU Corporation and the shares transferred in this transaction. SKY Perfect JSAT will continue to hold a majority of the issued shares of SPP (51%), and SPP will remain a consolidated subsidiary of SKY Perfect JSAT, continuing to promote its business with a core focus on IP (intellectual property) creation and development.

Since its establishment in April 2024, SPP has been engaged primarily in the planning and development of IP, with a focus on animated works, and achieved profitability in its first fiscal year. Positioning this share transfer as part of a strategic capital alliance, SKY Perfect JSAT aims to further strengthen the collaborative framework between SPP and iRightsport, building on the relationship cultivated with the ITOCHU Corporation Group to date. Through this collaboration, the companies seek to establish an integrated business structure encompassing IP planning and development, license management, and overseas expansion.

SKY Perfect JSAT will continue to work toward enhancing corporate value and achieving sustainable growth for the entire group through collaboration with strategic partners.
