**Announcement Regarding the Status of Share Repurchases
(Acquisition of treasury stock pursuant to Article 459-1 of the Japanese Companies Act and
the company's Articles of Incorporation)**

GMO Internet Group, Inc. (the Company) hereby announces that the Company repurchased its own shares in accordance with Article 459-1 of the Japanese Companies Act and the Company's articles of incorporation, as resolved at the Board of Directors meeting held on November 25, 2025.

With regard to the acquisition and cancellation of treasury stock, as announced in the press release "Notice of Revision to Shareholder Returns Policy with Long Term Share Buyback Plan" published on July 30, 2015, we will continue to implement the acquisition and cancellation of approximately 38.35 million shares, which is the number of shares issued when the capital was increased due to withdrawal from loan credit business from 2006 to 2007.
