Notice of Change in Major Shareholders

NISHIO HOLDINGS CO., LTD. ("the Company") hereby announces that a change in a major shareholder of the Company is expected to occur on August 22, 2025.

1. Circumstances behind Change

On August 22, 2025, the Company received contact from its major shareholder Nishio Trading YK to the effect that it intended to transfer 3,060,000 of the Company shares that it holds to Sanko Kihan Co., Ltd. ("Sanko Kihan") over single-stock trading (ToSTNeT-1) on the Tokyo Stock Exchange. Such transfer is expected to result in a change in major shareholders.

Note that the Company has received a report that Sanko Kihan is an asset management company in which Mr. Masashi Nishio, President of the Company, and his relative hold shares.
