## Notice of Change of Trade Name and Relocation of Head Office of Consolidated Subsidiaries

ISB CORPORATION ("ISB") hereby announces that, at a meeting of ISB's Board of Directors ("Board") held on November 10, 2025, the Board resolved to change the trade name of SSS Corporation ("SSS"), a consolidated subsidiary of ISB, ("Trade Name Change") and to change the trade name of Computer House Corporation ("Computer House"), a consolidated subsidiary of ISB, and relocation the head office of Computer House ("Trade Name Change and Head Office Relocation").

The Trade Name Change and the Trade Name Change and Head Office Relocation will be effected by a resolution to amend the articles of incorporation at the general meeting of shareholders of the respective consolidated subsidiaries.

#### 1. Purpose of the Change of Trade Name and the Relocation of Head Office

As stated in the "Notice of Group Reorganization (Acquisition of Business from Consolidated Subsidiary and Transfer of Business between Consolidated Subsidiaries)" disclosed on August 7, 2025, ISB decided to acquire business from a consolidated subsidiary and a transfer of business between its consolidated subsidiaries in order to improve business management efficiency of the ISB group ("ISB Group") and strengthen its regional strategy to increase added value.

This change of trade name of the subsidiaries aims to further enhance their visibility by defining its business development well-tailored to the characteristics of each region and customer needs, while also establishing its brand as a member of the ISB Group. The relocation of the head office aims to strengthen cooperation with local companies and further improve business management efficiency by consolidating the head office functions.

Through these initiatives, we will strive to enhance the brand value in each region, deepen cooperation with local communities, and develop our business and company value.
